  - e. CAC for facilities (Ed Poprik) Continuing work on High School, Corl St. Radio Park and Spring Creek. All four are scheduled to be finished in August 2019. Playground master planning process is beginning to look at improvements. Memorial Field project is also in the works. Counseling office completion was accelerated so that it will be finished in February instead of August.
5. All Hazards Update meeting August 1, 2018
  - a. Adam Salyards - [Discuss building construction and fences](#) : Adam discussed the fence around the high school and pointed out Crime Prevention Through Environmental Design principles, meaning that the fence is doing what it intended to do....student cross Easterly at set intersections where crossing guards are present. There is not a gate in the center b/c is would create a choke point and cause a greater hazard. (Recommends, not putting a gate there.) Students should run for cover or concealment, which means not straight out where a gate would be. Guides visitors naturally to the office and highlights a person who might be trying to climb over a fence.

  - d. November 2 organized training for secretaries
  - e. Quick reference flip chart - approved and copies made for all staff and extra for substitutes
