5. I understand that there are inherent and other risks involved in the sport for which this equipment is to be used, snow skiing, that injuries are a common and ordinary occurrence of the sport, and I freely assume those risks.
6. I understand that the ski-boot-binding system will not release at all times or under any circumstances, nor is it possible to predict every situation in which it will release, and is therefore no guarantee for my safety.

I hereby release the ski shop and its owners, agents, and employees from any and all liability for damage and injury to myself or to any person or property resulting from negligence, installation, maintenance, the selection, adjustment and use of this equipment, accepting myself the full responsibility for any and all such damage or injury which may result.
8. I have made no misrepresentations to the ski shop in regard to my height, weight, age, or skier ability.
9. I verify that the visual indicators on my bindings correspond to the settings as shown on this rental agreement form.
10. All instructions on the use of my rental equipment have been made clear to me, and I understand the function of my equipment.
